- Assessing and managing risks, utilising the principles of prevention.
- Maintaining a safe and healthy workplace, safe systems and methods of work and safe equipment.
- Taking account of Health & Safety issues and providing information, particularly about materials and substances, for the end users of our services.
- Providing staff with the information, instructions, training and supervision they need to work competently, safely and in a healthy manner.
- Encouraging the use of and adherence to the relevant Approved Codes of Practice and industry best practice.
- Maintaining safe and unimpeded access and egress from the site and buildings, particularly for emergencies.
- Managing the use of safe procedures, tools, plant, equipment and the appropriate use of Personal Protective Equipment (PPE).
- Maintaining adequate levels of welfare facilities for the work force, including contractors.
- Assessing and minimising the impact of the sites' activities on the environment.
- Identifying and providing health and safety training to promote awareness of safety and wellbeing.
- Assess and manage any work-related stress, support workers mental health and well-being and take steps to remove or reduce as far as reasonably practicable.
- Making staff aware of their individual responsibilities to take reasonable care for the safety of themselves and others and co-operate with the management in matters of safety.
- Encouraging full and effective consultation with all staff on Health & Safety matters.
- Appointing an independent professional Safety Advisor to carry out regular inspections and audits.

Our approach to managing Health & Safety is set out in a separate document - Health, Safety & Environment at City & Country. It is however of critical importance that all persons employed on or wishing to enter a City & Country site recognise their own responsibility for Health & Safety and the important role they play in helping us to achieve a healthy and safe working environment by:

- acting responsibly
- having due regard to their own Health & Safety
- considering other people's Health & Safety
- following any instructions given to them by their supervisors
- co-operating on all Health & Safety matters
- following all Health & Safety rules, regulation, legislation and Site Rules
- using the Health & Safety equipment provided
- reporting any defects in equipment, plant or tools to their supervisor
- communicating effectively and co-operating with the Principal Designer

All Consultants, Professionals, Subcontractors, Suppliers and their employees will be required to perform in a similar manner, so that the requirement of their own Health & Safety Policy and our Health & Safety Policy are not jeopardised.

This Policy will be reviewed and revised where necessary on at least an annual basis.
